In case of any revision in the same or if any other levy/charge is introduced, the same shall be recovered from the allottee(s) as per terms in application form for provisional allotment.
- The Company would pay to the Allottee(s) Rs. 50/- per sq. yard per month of area of the plot for any delay in offering possession of the plot beyond the period as stipulated in the agreement to sell. Similarly, the Allottee(s) would also be liable to pay holding charges @ Rs. 50/- per sq. yard per month of the area of the plot if the Allottee(s) fails to take the possession of the plot within 30 days from the date of issuance of final notice of possession.
- The maintenance charges @ Rs. 1.50/- per sq. yard (indicative / approx.) per month of area of the plot for a period of three years, shall be payable in advance along with the notice of possession.
- The above Prices/Payment Plans are subject to revision / withdrawal at any time without notice at the sole discretion of the Company.
