

## Notice inviting claims for refund of FD amount from Sr. Citizens holding FDRs under Unitech's Fixed Deposit Scheme

### 1. Hon'ble Supreme Court's Order dated 29.04.2026:

It is hereby notified for the information of all FD Holders that on the recommendations of the Government appointed Board of Unitech Limited, the Hon'ble Supreme Court was pleased to direct the Management of the Company to invite claims of the FD Holders who have attained the age of 60+ and also for the cases wherein the FD Holder has passed away.

The relevant extract of the Hon'ble Supreme Court's Order dated 29.04.2026 (which is also uploaded on the website of the Company) is reproduced herein for ready reference:

*"20. The Board shall invite claims from Senior citizens fixed deposit holders in 4 categories i.e. (i) above the age group of 80 years as on 31/3/2026, (ii) between the age group of 70 and 80 years as on 31/3/2026 (iii) between the age group of 60 and 70 years as on 31/3/2026 and (iv) cases where the original fixed deposit holder has passed away.*

*21. The claims shall be invited through a Public Notice uploaded on the website of the Company to a designated email ID within a time bound manner within 8 weeks along with the supporting documents including the proof of date of birth etc. and the information shall thereafter be collated and placed before this Court for further directions/disbursal."*

### 2. Procedure to be followed by the concerned FD Holders:

- (i) FD Holders/ Legal Heirs of FD holders above the age group of 80 years as on 31.03.2026;
- (ii) between the age group of 70 and 80 years as on 31.03.2026;
- (iii) between the age group of 60 and 70 years as on 31.03.2026; and
- (iv) cases where the original fixed deposit holder has passed away

are requested to register their claims by sending an email at [unitechfd@unitechgroup.com](mailto:unitechfd@unitechgroup.com) with subject line: "Refund under age group of \_\_\_\_\_ (applicable age bracket to be mentioned)/ Refund in lieu of deceased FD Holder, **latest by the 30<sup>th</sup> June 2026.**

### 3. Applicants are requested to send a clear scanned copy of the following documents attached with the email only in pdf/jpeg file format:

- (i) Fixed Deposit Receipt (FDR);

- (ii) PAN Card (self-attested copy);
- (iii) Aadhaar Card (self-attested copy);
- (iv) Proof of Date of Birth (self-attested copy)

Incase original Fixed deposit holder has passed away, following documents are required to be submitted:

- (v) Fixed Deposit Receipt (FDR);
- (vi) Death Certificate (Self attested copy)
- (vii) Heir Certificate (In case Nomination is not registered)
- (viii) The documents as mentioned in (ii) &(iii) of nominee or Heir as the case may be.

#### **4. Claim Management process:**

On submission of the claims by the concerned FD Holders, Unitech's Management will collate the claims under the four categories and would further publish the report of compilation on the Company's website inviting objections, if any.

On collation of the final claim amounts, the same would be placed before the Hon'ble Supreme Court for adjudicating the release of the same from out of the balance funds lying with the Registry of the Hon'ble Supreme Court.
