UPON hearing the counsel the Court made the following O R D E R

- During the course of hearing on 18.12.2024, it was 1. suggested that a joint meeting of the Government-appointed Board of Officer of Unitech and the Chief Executive NOIDA/Greater NOIDA be convened by Hon'ble Mr. Justice Abhav Manohar Sapre (Retd.), a former Judge of this Court, who had been entrusted the responsibility of advising the Board. Consequently, a request was made to Hon'ble Mr. Justice Abhay Manohar Sapre (Retd.) to convene the meeting for the purpose of an amicable resolution of some of the issues pending between Unitech, on the one hand, and NOIDA, on the other.
- 2. Pursuant thereto, Justice Abhay Manohar Sapre (Retd.) has sent an Interim Report dated 15.01.2025, in which after referring to the details of those who attended the meeting (including Mr. Mahesh Jethmalani, learned Senior Counsel for NOIDA), it is pointed out that Unitech, in their response filed on 12.01.2025, has raised the following five issues:
 - "i. Release of Untreated sewage effluent from its Master Sewer onto the project site in Sector 96-97-98 which has left about 50 acres of land inundated with the same.
 - ii. Shortfall of 6.65 acres in possession of Sector 117 land and 18.17 acres in Sector 113, which is liable to be given as per the lease deed.
 - iii. Status of ownership/acquisition of 5.74 acres of land in Sector 113, of which possession was given on 10.07.2014, and which is being contested by the said landowner.
 - iv. Demarcation of land boundaries in Sectors 113 and

- 117 wherever it abuts the land of which possession has not been given.
- v. Disputes about acquisition of the lease land, of which possession has not been given."
- 3. In the Joint Meeting, the following decisions were taken in response to these issues:
 - "i. NOIDA has already deployed dewatering machines of higher capacity. Tenders for civil work to repair the breached potion of the wall will be floated soon. NOIDA agreed that the issue will be resolved and closed within a period of 6-8 weeks.
 - ii. NOIDA and Unitech's officials will coordinate and fix a date for demarcation of boundaries of land in all the 03 project sites, of which possession is not being given at this stage. Measurement of this area shall also be done jointly. NOIDA will take assistance from the Commissioner of Police and District Collector, wherever necessary, to ensure law and order situation does not arise at ground.
 - iii. Noida will make the position of ownership of land measuring 5.74 acres of land clear vis-a-vis the concerned landowner in Sector 113, and possession will be restored with the help of law enforcement agencies. NOIDA will write to the Commissioner of Police and Collector (with copy to Unitech) to fix a date for taking back possession of the land in a time bound manner.
 - iv. Out of 1.52 hectares of land in Sector 96-97-98, NOIDA will write to the Collector to get 5,760 sq. meters land demarcated so that possession of that area is taken without any encumbrance. In respect of the

balance 5,760 sq. meters, NOIDA will undertake steps for its acquisition."

- 4. The Interim Report reveals that the following three issues remain for deliberation and will be taken up in the next meeting for further discussion:
 - "i) NOIDA will give details of those lands, of which possession has not been given, based on the position of acquisition/pendency of court cases/or it being government land.
 - ii) It was stated on behalf of Unitech that in cases where possession of leased lands, in all the 03 projects, is not being given by NOIDA at this stage, on the ground of non-acquisition or not being in its possession, then whenever NOIDA gets/acquires that land, UNITECH should have the first right over the same and it should not be allotted to any third party.
 - iii) Deliberations on the outstanding dues of NOIDA after submission of detailed calculations and response from NOIDA and the response of UNITECH to the same as already directed in the first meeting held on 08.01.2025."
- 5. The next meeting is now fixed for 21.01.2025. We have impressed upon Mr. Mahesh Jethmalani, learned Senior Counsel representing NOIDA, to spare some time and join the proposed meeting as his presence signifies a serious initiative to resolve the pending issues.
- 6. At this stage, it is also pointed out that vide order dated 04.12.2024, passed in I.A.No. 241599/2024, the directions issued earlier on 26.04.2024 to the Chief Executive Officer, NOIDA, for the grant of approvals and sanction for the entire leased area including the Second Segment, as per the revised layout plan

submitted by Unitech for all the three projects, spread over parts of Sectors 96, 97 and 98, NOIDA, were reiterated. It was expected that the needful shall be done within a period of two weeks. We are informed by the Chairperson of the Board of Directors of Unitech that the compliance of the directions dated 26.04.2024, as reiterated on 04.12.2024, is still awaited.

- 7. Let an appropriate decision be taken by the Chief Executive Officer, NOIDA in this regard and if there are hiccups, let this matter be also taken up in the meeting proposed to be held on 21.01.2025, and a separate compliance affidavit in relation thereto may be filed before the next date of hearing.
- 8. The Interim Report, submitted by Hon'ble Mr. Justice Abhay Manohar Sapre (Retd.), at para 16, further points out as follows:
 - "16. In addition, the Hon'ble Court may also consider proper to pass appropriate directions to the Commissioner of Police and District Commissioner of the State to take all necessary steps and extend their full cooperation for implementation of the agreed issues set out in para 11 above which alone will enable the parties to ensure its compliance and implementation in letter and spirit within the time fixed for the purpose."
- In this regard, Mr. Shailesh Sharma, learned counsel for 9. the State of Uttar Pradesh, on our asking, undertakes that the requisite police force shall be deployed at all the three sites to ensure that no obstacle or impediment is caused by anyone in the ongoing projects of Unitech; no encroachment is takes place and no Unitech properties at the damage is caused to the Police, Noida, will communicate Commissioner of the full particulars, including the contact numbers of the Nodal Officer, to the Chairperson of the Board of Directors of Unitech, and such Officer will ensure compliance of the above-mentioned directions and the undertaking to be given on behalf of the State.
- 10. The Nodal Officer shall submit a compliance affidavit in this regard, after deploying the requisite police force on all the three sites, along with the details of the man-power/police

officers deployed at the sites.

- 11. The Nodal Officer shall also ensure that the requisite police force is permanently deployed at the site till the ongoing projects are completed.
- 12. We have been informed that Mr. Manish Mishra, Additional Deputy Commissioner of Police, Noida (Mob. No. 8595902511) has been appointed as the Nodal Officer to ensure compliance of the abovementioned directions issued by this Court.
- 13. Justice Abhay Manohar Sapre (Retd.) in his Interim Report has also pointed out that an e-mail regarding the meeting convened on 13.01.2025 was sent at the official e-mail address of the Chief Executive Officer of Greater NOIDA but there was no representation, either by an official or their counsel, in the said meeting. A fresh notice has been sent for the next meeting to the abovementioned Authority. Mr. Ravindra Kumar, learned Senior Counsel representing Greater NOIDA, submits that there was some miscommunication which led to the aforestated absence, and he assures that the next meeting will be duly attended by the Chief Executive Officer of Greater NOIDA.
- 14. At this stage, it is pointed out that after obtaining statutory approval of the Environmental Clearance for the projects in Sector-117, NOIDA, in November, 2024, the matter is now pending before the Chairperson of U.P. State Pollution Control Board for the grant of Consent to Establish (`CTE'). We, therefore, direct the above-mentioned State Authority to issue the requisite CTE, subject to compliances, if any, to be made by the Unitech, within a period of two weeks. Mr. Shailesh Sharma, learned counsel for the State of U.P., agrees to mail a copy of this order to the Chairperson, U.P. State Pollution Control Board for compliance, and the Secretary of the said Board shall submit an affidavit along with requisite CTE.
- As regard to the compliance of para 2 of our order dated 04.12.2024 passed in I.A. No. 77858/2024 and I.A. No. 77859/2024, we are informed that the process is ongoing and the Prescribed Authority in the State of Haryana is likely to do the needful in

due course of time.

- 16. Adverting to Part III of the Note for Hearing dated 16.01.2025, submitted by the Office of the learned Additional Solicitor General of India, we find that Unitech has sought two directions to the banks/financial institutions as follows:
 - (i) where the banks/financial institutions have already sanctioned home loans to the home-buyers but had stopped payments of the balance dues on account of the projects not movina forward, thev may be directed to release outstanding dues in view of the fact that the projects have now been revived; and (ii) with respect to the unsold units, the loan may be sanctioned for the units that may be sold in the ongoing projects in future.
- 17. We find that before issuing directions in this regard, the banks/financial institutions need to be heard. Hence, notice of the IA may be issued to the following banks/financial institutions, returnable on 06.02.2025:
- 1. IDBI Bank, LIC, Canara Bank (I.A.No.84255/2020)
- 2. IDBI Bank, LIC, Canara Bank (I.A.No.6512/2021)
- 3. IDBI Bank, LIC, Canara Bank (I.A.No.9494/2022)
- 4. IDBI Bank, LIC, Canara Bank (I.A.No.28098/2023)
- 5. **IDBI Bank (I.A.No. 50055/2023)**
- 6. Alchemist Asset Reconstruction Company (I.A.No.29922/2021)
- 18. Ms. Anubha Agrawal, learned counsel, accepts notice on behalf of the non-applicant(s)-Banks.
- 19. Reply, if so required, be filed within two weeks.
- 20. We also take this opportunity to impress upon the applicant-banks/financial institutions to engage in dialogue with the Management of Unitech and explore the possibility of One Time Settlement (`OTS') in furtherance of the the interest of the parties. Accordingly, the applicant-banks/financial institutions will be at liberty to approach the Management of Unitech for OTS.
- 21. Having regard to the fact that the ongoing Unitech projects are being monitored by this Court and are being executed by the Government appointed Board of Directors, which is further

being advised by a former Judge of this Court appointed under the order of this Court, and also that the periodical reports with regard to the completion of the projects will be submitted before us, we find it in the interest of justice to dispense with some of the procedural requirements in order to facilitate the release or advancement of house loans to the home-buyers of different Unitech projects. We, accordingly, direct that all the ongoing projects of Unitech shall remain exempted from registration under RERA till further orders.

I.A.Nos. 784, 8716 of 2025 and I.A.Nos. 9000, 9001 and 9002/2025

- 1. Let notice be issued to the respondents, returnable on 06.02.2025.
- 2. Dasti, in addition, is permitted.

I.A.No.286583/2024

- 1. Learned Additional Solicitor General of India informs that the requisite change of option has duly been registered in the Portal and hence, the instant application has become infructuous, and the same may be disposed of as such.
- 2. The application is, accordingly, disposed of as having become infructuous.

I.A.Nos. 293714/2024 and 293716/2024

- 1. Learned Additional Solicitor General of India seeks and is granted two weeks' time to file reply to these applications.
- 2. Let the needful be done with an advance copy to the applicant(s).

I.A.No. 115357/2024 in SLP(Crl.)Nos.5978-5979/2017

- 1. The instant application has been moved by M/s Pioneer Urban Land and Infrastructure Limited seeking a refund of the balance amount lying with the Registry of this Court.
- 2. Vide order dated 05.03.2018, the applicant was directed

by this Court to deposit a sum of Rs.40 crore for the purpose of refund of the amount to 47 home-buyers to whom the residential units were allotted in the project which was to be executed by the applicant-M/s Pioneer Urban Land and Infrastructure Limited in collaboration with Unitech. We are informed that out of 47, 39 home-buyers/customers have received 100% of their principal amounts as refund. Five customers/home-buyers have executed Settlement Agreements with Unitech and have opted for taking possession and hence no amounts are required to be refunded to them.

- 3. As regard to the remaining three home-buyers/customers, they have not filed the requisite documents for refund of the amounts so far. In addition, one of the home-buyers Ms. Rani Ranjit Kamran, who is not registered on the web portal, has filed I.A.No. 77925/2020 seeking refund of approximately Rs.23.80 lakhs, which was deposited by her. We are further informed that out of Rs.40 crores, deposited by the applicant, approximately Rs.10 crores is currently lying with the Registry of this Court.
- 4. With the consent of the parties, the Registry is directed to:
 - (i) refund a sum of Rs.23.80 lakhs be refunded to Ms. Rani Ranjit Kamran, subject to her furnishing requisite documents re: identity etc. to the satisfaction of the Registrar (Judicial) of this Court;. (ii) since the claim of three home-buyers/customers is yet to be ascertained, the Registry will retain a sum of Rs.3 crores with itself; and
 - (iii) consequently, the balance amount which equals approximately Rs.7 crores shall be refunded to M/s Pioneer Urban Land and Infrastructure Limited.
- The needful shall be done within two weeks.
- 6. Since 39 home-buyers/customers have been refunded 100% of their principal amount and one more customer/home-buyer has been granted refund, it goes without saying that the 40 units allotted to them will revert to M/s Pioneer Urban Land and Infrastructure Limited free from all encumbrances qua these allottees. M/s Pioneer

Urban Land and Infrastructure Limited will be at liberty to appropriate those units in the manner as it may deem fit.

7. The set of documents deposited by 39 customers-cum-home-buyers with the Registry of this Court, seeking refund, may be handed over to M/s Pioneer Urban Land and Infrastructure Limited to enable them to complete their records.

I.A.No. 234374/2023

- 1. Since the issue involved in this I.A. has no bearing or relevance to the main case, and has previously directed the Registry to de-tag the same, let this matter be separately listed in terms of the order dated 22.11.2024.
- 2. Mr. P. Chidambaram, learned Senior Counsel for the applicant(s) informs that the Registry has again listed this I.A. as a part of the main matter.
- 3. The aforesaid I.A is directed to be de-tagged and the Registry shall ensure that it will be listed separately for hearing on 23.01.2025.
- 4. Let notice be issued in this I.A. to the NCT of Delhi through the Secretary, Department of Home and Jail; and also (ii) the Director General (Prison), Tihar Jail, returnable on 23.01.2025.
- 5. Dasti, in addition, is permitted.
- 6. Liberty to serve the respondents through standing counsel also.

I.A.Nos. 158534/2024 and 7750/2021

- 7. We have heard Mr. Aman Gupta and Mr. Parthasarthy Bose, learned counsel, representing Mr. Mohinder Khaira and Mr. Naresh Kempanna, who have failed to deposit the requisite amount along with interest, notwithstanding the categorical directions issued by this Court vide orders dated 23.03.2023 and 09.10.2023.
- 8. Before we entertain the objections filed by them for the purpose of recalling/modification of our orders dated 23.03.2023

- and 09.10.2023, Mr. Mohinder Khaira and Mr. Naresh Kempanna, are directed to *prima facie* purge the contempt and deposit the amount of Rs.98.07 crores, along with interest accrued thereon till 31.01.2025, within a period of four weeks, with the Registry of this Court and submit a compliance affidavit to that effect.
- 9. As soon as the amount is deposited, the Registry is directed to list their applications along with Contempt Petition on 06.02.2025.
- 10. The amount so deposited shall be kept in a Fixed Deposit Receipt, in a nationalised bank, initially for a period of six months, with auto-renewal facility.
