India, representing the Chairman of the Board of Directors and Chief Executive Officer of NOIDA/Greater NOIDA submitted that the meeting, as suggested by Mr. Mahesh Jethmalani, learned senior counsel, may be convened by Hon'ble Mr. Justice Abhay Manohar Sapre, Former Judge of this Court, who has been entrusted the responsibility as an Adviser to the Board.

2. On our asking, Mr. Mahesh Jethmalani, learned senior counsel, has also graciously agreed to join the proceedings in-person or through online, as per his convenience.

3. We, therefore, request Hon'ble Mr. Justice Abhay Manohar Sapre to convene a meeting at the earliest and make an attempt to amicably resolve the issues between the NOIDA/Greater NOIDA and the Unitech, as represented by the Government constituted Management.

4. Learned counsel representing the State of Uttar Pradesh, on instructions from the Commissioner of Police, states that all necessary arrangements shall be made to ensure that no disturbance/impediment or hampering is caused by anyone in the ongoing lawful construction, being made by the Unitech through the Government constituted Board of Directors.

5. In this regard, the Commissioner of Police will be well advised to notify a nodal officer with whom the Management will coordinate in future to ensure the timely assistance at the spot.

6. The State of Uttar Pradesh may file its compliance affidavit before the next date of hearing.
