UPON hearing the counsel, the Court made the following  
O R D E R

I.A. No.261621/2024, I.A. No.257541/2024 & I.A. No.171096/2024

1. Issue notice, returnable on 16.01.2025.
2. Ms. Anubha Agrawal, the counsel assisting Shri N. Venkataraman, learned Additional Solicitor General of India accepts notice. A copy of the applications be supplied to the assisting

counsel of learned ASG.

3. Reply, if any, be filed within three weeks.

I.A. No.229159/2024

4. This application has been moved by the Government-appointed Board of Unitech Limited seeking the permission of this Court for disinvestment of M/s. Unitech Power Transmission Limited ('UPTL'), which is a wholly owned subsidiary of Unitech Limited. It is *inter alia* submitted that proposal for disinvestment of UPTL was unanimously approved by the Government appointed Board of Unitech Limited and thereafter permission of this Court was obtained for the sale of UPTL on a previous occasion. The same, however, did not materialize as the proposed buyers failed to deposit the agreed sale consideration. Initially, an offer over Rs.100 crores was received from Sterling & Wilson Private Limited. However, they failed to deposit the requisite amount. This fact was, accordingly, brought to the notice of this Court, and vide order dated 23.03.2021, this Court after noting that sale of UPTL to Sterling & Wilson Private Limited did not fructify, permitted the management of Unitech to explore other potential buyers for sale of its shareholding in UPTL. Thereafter, fresh offers were received, including one by M/s. Auro Infra Private Limited, dated 24.05.2024, depicting the valuation of Rs.45 crores for UPTL. Negotiations were held and the aforementioned prospective buyer then agreed to pay a sum of Rs.50.89 crores.

5. In their efforts to fetch the maximum price for UPTL, a public notice was issued on 19.07.2024 informing the general public that one prospective investor/buyer has quoted a bid amount of Rs.50.89

crores for acquiring 100% equity shareholding of M/s. UPTL on “*as-is-where-is-whatever-is-basis*”, and any investor who can submit a bid which is atleast Rs. 1 crore higher than the existing bid, and comply with certain other conditions, could instead be considered for the sale of UPTL. In this manner, before the transaction was finalized with M/s. Auro Infra Private Limited, the management had decided to take recourse to the Swiss Challenge Method, and provided an opportunity to all the investors/buyers, who may be interested to bid for the acquisition of UPTL.

6. Pursuant to the public notice, one offer of Rs. 55 crores was received by the management, but the prospective buyer did not comply with the conditions stipulated in the public notice, and did not deposit any performance-bank-guarantee. On the other hand, M/s. Auro Infra Private Limited vide their memo dated 17.09.2024 (a copy of which has been appended with the application) have confirmed their offer for necessary approval along with which they have also sent a post-dated cheque dated 16.12.2024 in the sum of Rs.50.89 crores, signaling their intent and *bona fides* to purchase UPTL.

7. We have heard learned Additional Solicitor General of India in support of the prayer made in this application and perused the relevant documents.

8. In light of the fact that the value of assets of UPTL is rapidly deteriorating, as is depicted in a tabulated form in paragraph 22 of the application, coupled with the fact that no alternative offer higher than M/s. Auro Infra Private Limited has been received by the management despite wide publicity having been given through public notices, we are satisfied that it will be in

the interest of Unitech and its subsidiary that the highest bid received as of now in the sum of Rs.50.89 crores is accepted.

9. Consequently, we allow this application and approve the proposal. Ordered accordingly.

10. Issue notice, returnable on 16.01.2025.

13. For the purpose of giving effect to this Court's order dated 22.10.2024 passed in I.A. No.241604/2024, and as prayed for by learned Advocate-on-Record appearing on behalf of Management of Unitech, (i) State of Uttar Pradesh, through Principal Secretary, Home Department; (ii) The Commissioner of Police, Gautam Buddh Nagar, Uttar Pradesh and (iii) The Collector, Gautam Buddh Nagar, Uttar Pradesh are directed to be impleaded as party respondents.

14. Issue notice to the newly added respondents, returnable on 18.12.2024.

15. Dasti service, in addition, is permitted.

16. The newly added respondents may also be served through the standing counsel for the State of Uttar Pradesh.
